## FORT WORDEN FULLY ACCESSIBLE ENTERTAINMENT VENUES

Centrum 360-385-3102

#### **BUILDING 204, Battery Way**

Ramp has 2" lip.
Difficult door; use double doors at right.
Restrooms doors are heavy.
Elevator space is tight.

#### **BUILDING 306, behind USO Building**

Unmarked accessible parking nearby. Restroom lacks grab bars, lever handles, signage.

### RAINSHADOW RECORDING, BUILDING 315 West, 200 Battery Way

Unmarked accessible parking on sodded packed dirt.

Shallow ramp planned for 4½" entrance step. Call ahead if help needed 360-385-5665. Accessible restrooms at the Commons.

#### THE CHAPEL, Fort Worden Way main entrance

Accessible parking in paved lot at USO building on Eisenhower or in the unmarked lot opposite Chapel.

#### THE COMMONS, Building 210, 200 Battery Way

Restroom doors very heavy.

#### JFK BUILDING, Alexanders Loop

Rough surface to entrance.

Unmarked automatic door.

Problematic women's restroom faucet, door and placement of toilet roll in accessible stall.

#### McCURDY PAVILLION, off Eisenhower

Accessible parking across Eisenhower.

Accessible entrance/unloading in back No-Parking area; arrange accessible parking ahead.

Men's restroom door heavy; women's very heavy.

#### **USO BUILDING**, on Eisenhower opposite McCurdy

Accessible parking at side of building near ramp.

#### WHEELER THEATER, Eisenhower & Fort Worden Way

Accessible paved parking across Eisenhower.

Call ahead for accessible seating.

Accessible restroom across Eisenhower at Taps at the Guardhouse pub, enter at rear of building; also for use at **McCurdy Pavilion** concerts on **Littlefield Green**.

Maneuverability in women's restroom difficult.

AMERICAN LEGION HALL, Monroe & Water (Downtown), 360-385-3454 \*

Ramp on Water Street. Heavy doors.

BOILER ROOM, 711 Water St. (Downtown), 360-379-8247 \*

THE CHAMELEON THEATRE, 800 W Park Ave. (Upper Sims), 360-379-1068

#### CHETZEMOKAPARK, Main entrance at Jackson & Blaine (Uptown)

Accessible restroom near main entrance.

Many grassy and unpaved areas.

See Key City Public Theatre regarding Shakespeare in the Park.

COTTON BUILDING, 607 Water St. (Civic District) \*

#### FIRST BAPTIST CHURCH, 1202 Lawrence Street (Uptown), 360-385-2752 \*

Ramp at rear, handrail one side only, steep threshold at top of ramp.

Unmarked accessible parking close to ramp.

Restroom door and faucets have knobs.

Hazardous step outside restroom not easily visible.

Fellowship Hall ramp faces Lawrence; bathrooms not accessible.

#### FIRST PRESBYTERIAN CHURCH, 1111 Franklin Street (Uptown), 360-385-2525

Accessible parking has soft gravel base.

Restroom doors very heavy and have knobs.

#### HIGHWAY 20 ROADHOUSE, 2152 W Sims Way (Upper Sims), 360-385-7747

Accessible entrance at side.

Ask for accessible restroom location.

#### JEFFERSON COUNTY FAIRGROUNDS, 4907 Landes Street (North Beach) 360-385-1013

Erickson Building has steep ramp, no accessible restrooms.

Art Building is fully accessible.

4-H Building has no accessible restrooms.

#### KEY CITY PUBLIC THEATRE, 419 Washington Street (Downtown), 360-385-7396 \*

Call office 360-379-0195 to reserve accessible row seating, wheelchair seating and assistive listening devices. Call office for golf cart transport from Theatre entrance to **Shakespeare in the Park** performance site in Chetzemoka Park and to/from restrooms.

#### OWL SPRIT RESTAURANT, 218 Polk Street (Downtown), 360-385-5275

Steep ramp without handrails.

#### PALINDROME, 1893 S Jacob Miller Road, 360-531-2211

No sign directing to disabled parking at rear on firm grass, unloading onto gravel.

A 1" lip at ramp, no hand-rails.

No sign on accessible restroom, no grab bars.

(New owners are making accessibility improvements - April 2016.)

#### POPE MARINE BUILDING, Madison & Water Streets (Downtown)

Problematic for chemical sensitivity.

#### PORT TOWNSEND BREWING COMPANY, 330 - 10th Street (Boat Haven), 360-385-9967

Very heavy door.

Restroom door has knob.

#### PORT TOWNSEND CITY COUNCIL CHAMBERS, 540 Water Street (Downtown), 360-379-5047 \*

Accessible parking on Madison.

Accessible elevator at door on Madison closest to Water.

#### PORT TOWNSEND CIVIC DISTRICT, Madison & Water Streets area (Downtown) \*

Public restrooms open 7am to 9pm in the summer.

Closest marked accessible parking at Maritime Center, Madison above Water Street and between public restrooms and Elevated Ice Cream.

#### PORT TOWNSEND HIGH SCHOOL, 1500 Van Ness Street (Uptown), 360-379-4520

Ramp has 1½" lip. Use farther entrance for inside ramp.

Men's restroom door heavy; Women's very heavy, mirror high.

### PORT TOWNSEND COMMUNITY CENTER & SENIOR CENTER, 620 Tyler Street (Uptown), 360-385-9007

Restroom doors very heavy but Women's door is usually left open.

#### THE POURHOUSE, 2231 Washington Street, (Boat Haven), 360-379-5586

Short steep ramp to unmarked accessible front entrance, heavy doors. 1/2-1" lip from sidewalk to large loose gravel back space.

**OLD WHISKEY MILL, 1038 Water Street** (Downtown), **360-385-4422** \* Restroom use and access difficult.

TRINITY UNITED METHODIST CHURCH, 609 Taylor Street (Uptown), 360-385-0484 Unpaved parking; ramp on Tyler. Sanctuary restroom door and faucet have knobs. Fellowship Hall ramp at opposite side; heavy restroom door has knob.

**TURTLE BLUFF III, 523 Blue Ridge Road** (Cape George), **360-385-3626** *No designated parking, gravel surface. No grab bars in restroom.*

Parking and ramp at rear.

Artillery Hill video subtitles must be turned on.

Heavy restroom doors. Accessible stalls a little tight.

Accessible parking on Madison.

Accessible elevator at Madison door closest to Water.

**EARTHENWORKS GALLERY, 702 Water Street** (Downtown), **360-385-0328** \* *Very heavy door.*

**MAESTRALE, 821 Water Street** (Downtown), **360-385-5565** \* Very heavy door.

Step up to open back space, staff is helpful.

Main area and courtyard accessible.

**SUSAN FAUST, 210 Polk St., Suite 6A** (Downtown), **360-379-5191** \* Ramp to elevator. One accessible restroom for that floor.

LUKE J. TORNATZKY GALLERY, 833 Water Street (Downtown), 360-774-0770 \* Short steep ramp to heavy door, high threshold.
