## **Treasurer Report:**

Bonnie outlined the tools that DASH has ordered: Pressure gauges, measuring tape, electronic level, shoulder bag, camera: total amount \$425.50, weight 7lb.

Other items that could be ordered are leg and arm weights costing between \$11 and \$22.

Regular account has \$3213.32, plus the \$2500 just received.

Emergency account remains the same.

# Website updates:

## **Step-Up Program - Department of Emergency Management:**

Bonnie has been in contact with them regarding handling donations for the classes as DASH is custodian of the fund. There will be a class for people with disabilities this summer starting June 9 that we can put on DASH website.

## **Key City Public Theatre's need for golf cart transportation**

Marion reported on efforts to secure a golf cart to transport patrons for Shakespeare in the Park. Additional ideas were shared.

## ECHHO:

A device for driving assistance for Toyota Prius worth \$1200 is available from ECHHO.

ECHHO also receives non-functioning motor scooters that are sent to Seattle since they have no way of repairing them here. Boeing Bluebills is a possible resource.

## **Inclusive Recreation:**

At EDC training young professionals expressed interest in helping. Suggestion is for an online form that could be accessed online with a smartphone for data collection. Discussion about whether this belongs on Information page or Projects page. More discussion is needed.

Marion has a completed evaluation for Fort Worden ADA trail and Kah Tai Lagoon Park – both ready for website. Marion will attempt to find out what Jefferson Land Trust is doing with its data on accessible trails.

Future aspects of accessible recreation project could be swimming and bicycling.
